



## 2010 SDSMAPAC Board of Directors

The SDSMAPAC Board of Directors is composed of one physician member and one Alliance member of the South Dakota State Medical Association for each potential 50 members in each of the 12 district medical societies. If 50 percent of the potential members in a district join SDSMAPAC, the district is entitled to one additional physician and Alliance member; if 70 percent of the potential members in a district join SDSMAPAC, the district is entitled to two additional physician and Alliance members.
