Mary E. Fallat, MD, FACS, FACP, FAAP



Dr. Fallat is Professor of Surgery at the University of Louisville and an attending pediatric surgeon at Norton Children's Hospital where she has been in practice for over 35 years. She is former Surgeon-in-Chief at Norton Children's Hospital and Division Director of Pediatric Surgery. Interest areas include access to surgical care, trauma, and prehospital care, particularly in rural and underserved areas of the country.

Dr. Fallat has a history of service and leadership in Pediatric Surgery and Pediatric Trauma. She is the immediate past First Vice-President of the American College of Surgeons and focused on visiting rural ACS Chapters. Dr. Fallat has been funded by The Health Resources & Services Administration (HRSA) as program director for the Kentucky Emergency Medical Services for Children (EMSC) program since 2004. She serves as trauma advisor to the National Pediatric Readiness Program. She is a sub-Principal Investigator for the trauma/burn hub at Norton Children's Hospital for an awarded HRSA grant to develop a national pediatric pandemic network.

Michael Sutherland, MD, MBA, FACS



Dr. Sutherland earned a Bachelor of Science in microbiology from Louisiana State University, Baton Rouge, and his medical degree from Louisiana State University Medical Center School of Medicine, New Orleans.

Dr. Sutherland completed an internship in general surgery at Keesler USAF Medical Center, Keesler AFB, Mississippi, followed by a residency in general surgery, also at Keesler USAF Medical Center. After residency,

he completed a general thoracic and vascular surgery fellowship at Keesler USAF Medical Center and VA Gulf Coast Health Care System, Biloxi, Mississippi. He served in the Air Force for two years including a deployment to Balad Iraq in 2005.

His clinical practice has been focused on trauma center and trauma systems development. He has established trauma centers in Arkansas, Louisiana, and Ohio and served in leadership roles on the state and regional trauma systems in each of those states. He continues his clinical practice at Northwestern University in the Feinberg School of Medicine as an Acute Care Surgeon covering Trauma and Emergency General Surgery call in addition to his duties as the Director of the Division of Member Services at the American College of Surgeons.
